SEDI DATES EXTENDED

The Alberta Securities Commission issued a press release dated October 29, 2001, indicating a change of dates for the new reporting structure for insiders and issuers. Please note that the deadlines for meeting the SEDI requirements have been extended from previously reported in Parlee McLaws' Securities Legal Alert as follows, although the date for "going live" is still Monday, October 29, 2001:

- A) REGISTRATION FOR USERS IS AVAILABLE ON THE SEDI WEBSITE: OCTOBER 29, 2001;
- B) ISSUERS TO REGISTER AND FILE AN ISSUER PROFILE SUPPLEMENT ON SEDI: BETWEEN OCTOBER 29 AND NOVEMBER 19, 2001 (FORMERLY OCTOBER 29 TO NOVEMBER 2, 2001);
- C) INSIDERS' REGISTRATION AND FILING PROCEDURES AVAILABLE ON-LINE: DECEMBER 3, 2001 (FORMERLY NOVEMBER 13, 2001);
- D) MANDATORY ELECTRONIC FILING BY INSIDERS: DECEMBER 17, 2001 (FORMERLY NOVEMBER 13, 2001).

DEADLINES FOR MEETING THE SEDI REQUIREMENTS HAVE BEEN EXTENDED BY REGULATORS—DATE FOR "GOING LIVE" IS STILL MONDAY, OCTOBER 29, 2001.
